Opening

Good evening. On behalf of the MRC91 repeater, welcome to tonight's **Tasty Tuesday**.

Licensed Amateur Radio operators holding a Technician Class license or higher are encouraged to check in, with or without traffic. New operators are welcome.

Emergency or Priority Traffic

Before we begin, if any station has emergency or priority traffic during this net, please break in at any time. We will pause normal net operations and handle the emergency or priority traffic first.

Net Format

We will first take check-ins. After check-ins are complete, each checked-in station will be given an opportunity to participate in the discussion portion of the net.

If you do not wish to participate in the discussion portion, simply state **No Traffic** when checking in.

Check-In Instructions

Check-ins will be taken in alphabetical segments based on the first letter following the numeral in your call sign. Mobile and portable stations may check in at any time when it is safe to do so.

When checking in, please give your call sign slowly using standard phonetics, followed by your first name.

Mobile and Portable Stations

We will now begin with any mobile or portable stations. Mobile or portable stations, come now please.

[Acknowledge each station by repeating what you heard and logging the station.]

Alphabetical Check-Ins

We will now take check-ins by call sign segment:

A - Alpha through F - Foxtrot, come now please.

G - Golf through K - Kilo, come now please.

L - Lima through P - Papa, come now please.

Q - Quebec through V - Victor, come now please.

W - Whiskey through Z - Zulu, come now please.

Final Call Before Discussion

Before we begin the discussion portion of the net, are there any additional stations wishing to check in? Any station, A through Z, come now please.

Discussion Portion

We will now begin the discussion portion of tonight's **Tasty Tuesday**. Each checked-in station will be called in order and given an opportunity to share comments, questions, updates, stories, or other appropriate traffic related to tonight's topic.

Net Control may continue with an additional round if the discussion is active and time permits.

Net Control Reminders

Use your call sign at least every 10 minutes in accordance with FCC identification requirements.

If a call sign is unclear or read back incorrectly, ask the station to repeat it slowly using standard phonetics.

Please keep the net friendly, welcoming, and appropriate for all operators. Avoid topics that are likely to become controversial or divisive.

Are there any late check-ins, announcements, events, swap items, public service announcements, or final business for the good of amateur radio? Come now please.

[Handle any late check-ins or final business as needed.]
