

**MRC91 COMPUTER/TECH NET SCRIPT**  
**7 pm Thursday night**

“Good evening! On behalf of the MRC91 repeater, I would like to welcome you to the Thursday night computer/tech net”. My name is **(NAME/CALL)** and I am located in **(CITY)** and I will be acting as your net control operator for tonight's net. Licensed Amateurs, Technician class or higher are encouraged to check in either with or without traffic.”

“Before we start tonight's net however, if you should have an emergency during this net, please let us know and we will stop to handle your emergency.”

“Traffic for this net means questions, comments, problems or news about computers or other technical device's. Questions about the new digital modes or thinking about a new radio? Let's see if others can help you out. However, please note that we will not accept traffic offering to distribute copyrighted programs.”

“If you have anything you are looking to buy, sell or trade, we suggest you check in on the MRC91 repeater at 9pm Sunday nights for the Sunday night Swap net where this traffic is encouraged.”

“Lets get started, check ins are in alphabetical segments, based on the first letter following the numeral in your call sign. Mobile stations may ignore the roll call segments and check in at any time it is safe to do so. During check ins, please respond with your call sign **SLOWLY** in standard phonetics along your first name and whether you have traffic or not.”

“Again, this is **(NAME, CALL)** your net control operator this evening.”

“We will now begin check ins with any mobile stations: Mobile stations come now please.”

*(Acknowledge by repeating what you heard and logged, or “hearing none, we will take check ins from:)* Call sign segment suggestions:

**A-ALPHA** thru **F-FOXTROT**  
**G-Golf** thru **K-KILO**  
**L-LIMA** thru **P=PAPA**  
**Q-QUEBEC** thru **V-VICTOR**  
**W-WHISKEY** thru **Z-ZULU**

“**A -Alpha** thru **F-Foxtrot** come now please” (and so on)

*(When a net typically does not have a lot of check ins, it is suggested to do larger segments during the check in period, it is your call. Please remember to use your call sign at least every 10 minutes per FCC regulations. Also, ask your guests to repeat their call sign if you read it back incorrectly)*

*(Please take all check ins prior to the traffic portion of the net)*

*(Naturally if there is traffic it will be up to you, the Net Control operator to either try to answer the traffic if you can or ask if anyone else in the group can respond to the traffic. If neither you or any of those who checked in can answer the traffic don't feel bad as no one can know everything)*

*(At the end of the net ask for any final business or late check ins)*

Before we end tonight's net, is there any final business or late check-ins for tonight's net, if so come now please.

*(If there are any handle as needed or if none say)*

Hearing none, this net is now secure at \_\_\_PM. Thank you all for participating and a reminder that this net along with most of the other nets here on the MRC91 repeater welcome new operators to experience net control operation by trying a net or two. If you wish to try acting as a net control operator please contact our club president Karen, KC9WQJ to participate. All net scripts are on the club web site for your review.

At this point we will now return the repeater to normal amateur use.

Again, this is (NAME, CALL), 73 and good night.
